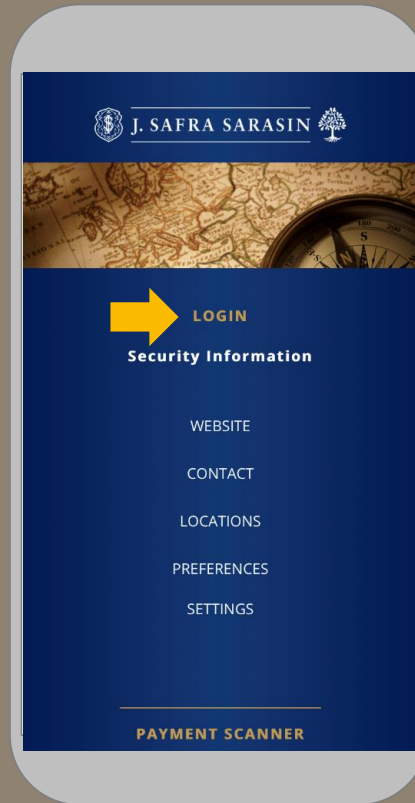

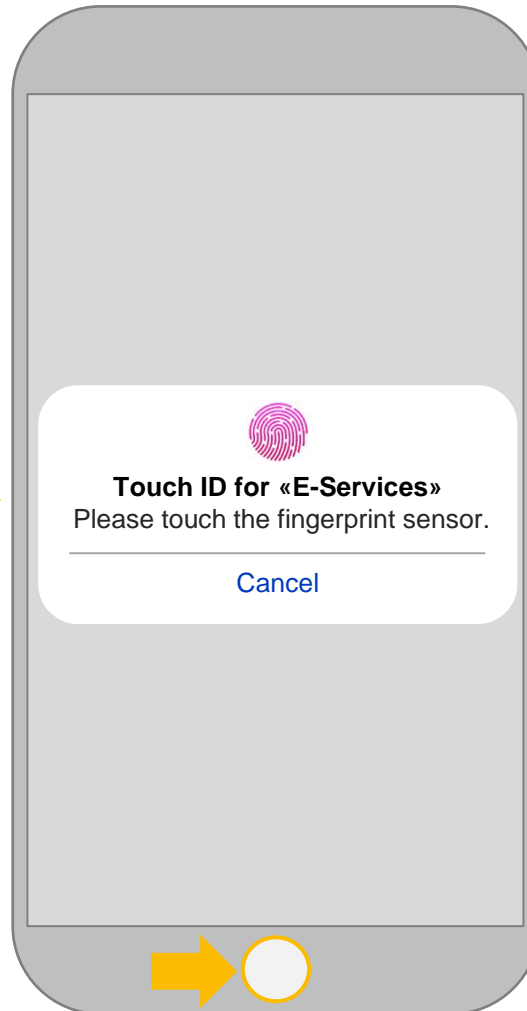
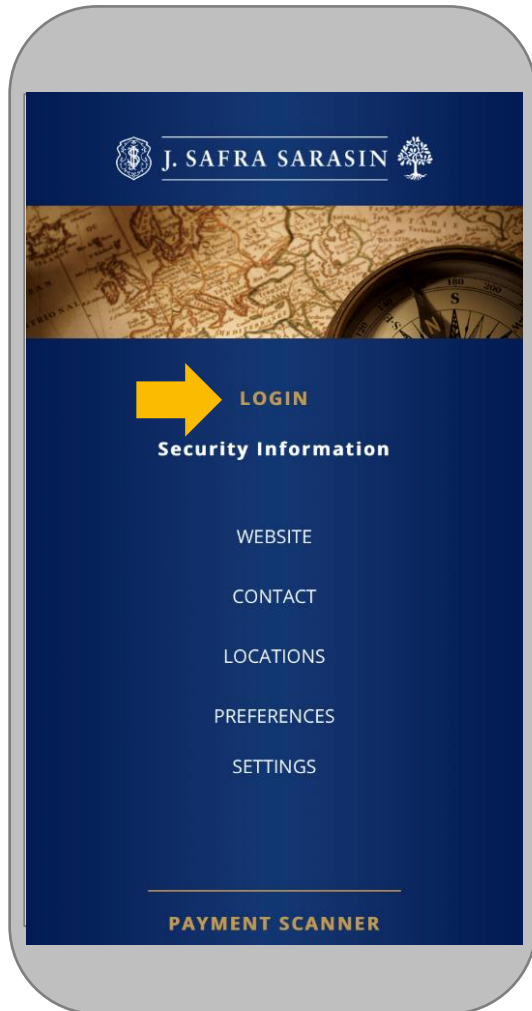
What does the Mobile Banking app offer?

- Dashboard: Quick overview of all main elements


